

Business Terms 2020

Prices:

Prices are effective April 1, 2020 – March 31, 2021. All prices are in US-\$ (US-Dollar) per 1,000 seeds and are subject to change without notice. Seed sold by seed count only. For more details, please contact your area sales manager or our customer service staff. We will invoice based on our pricing at time of shipment.

Minimum order size:

A \$ 30.00 USD service charge will be added to all orders below \$ 75.00 USD.

Packaging Fees:

All orders will be filled in bulk and/or predetermined packet sizes. For multiple packaging additional time may be required to complete the order.

500 seeds / pellets
1.000 seeds / pellets
2.000 seeds / pellets
5.000 seeds / pellets
10.000 seeds / pellets
25.000 seeds / pellets

For the smallest pack size available per item, please refer to the “minimum order quantity” next to each item in your price list.

If special packaging is requested, different than above, a packaging fee of \$ 0.50 USD per packet will apply and additional time may be required to complete the order.

Shipping and Documentation:

In addition to the costs mentioned freight costs and additional shipping documents (Phytosanitary Certificate, Certificate of Origin etc.) will be charged to the purchaser:

Shipping to Canada:

For shipments outside the continental USA, the goods are shipped at purchaser's risk. Charges for shipping costs, taxes, fees and insurance will be borne by the consignee. If import licenses are necessary, the number should be stated on the purchase order. As far as regulations permit, the instructions of the purchaser will be complied with.

Returns:

Complaints on outward appearance and on the weight of the seed must be logged within 7 days, complaints on the germination within 30 days from the day of shipping from any Ernst Benary facility.

Seed must be returned in the unopened original packing within 60 days of the ship date for full credit.

Seed returned within 61 days to 179 days of ship date, is subject to approval and a 15% restocking fee.

No credit or replacement will be given on seed that was returned 180 days (6 months) past original ship date.

No seed may be returned without first obtaining written authorization from Ernst Benary. Seed that is returned without authorization will not be accepted and credit will not be issued. No original open packages will be accepted.
